

# Efflorescence Blocker & Sealer

Efflorescence Blocker & Sealer enters the material capillaries and uses the available  $H_2O$  and atmospheric  $CO_2$  to form an efflorescence blocking network, the hydrophobic property then develops in the direction of the available moisture supply.

Efflorescence Blocker & Sealer is ideal for use on floors, such as block paving, concrete & stone. Also suitable for brick walls and roofs. Treatable materials include concrete, concrete blocks, masonry, mortar, plaster, stucco and natural stone.



## IMPORTANT BEFORE USE

Ensure surface is clean and free of paint, sealer, oil, adhesive, curing compound, form release agent and/or anything that will prevent the product penetrating the surface. Any previously applied sealers must be removed before proceeding. DO NOT APPLY product to aluminum, glass, glaze tiles or shiny surfaces. Avoid contact with shrubs, plants and lawn. Keep children and pets away until surface is fully cured. Do not apply when ambient/surface temperature is below  $+10^{\circ}C$  or above  $+25^{\circ}C$ . Do not apply in wet weather or when rain is imminent. Always test a small inconspicuous area before use to ensure surface compatibility, performance and finish/texture is acceptable.

## APPLICATION

- Apply using a spray, roller or brush.
- Whilst the product can be applied to damp surfaces ensure there are no standing water or puddles present.
- Apply the first treatment at the rate of  $5\text{ m}^2/\text{litre}$ , keeping the surface wet with product for at least 30 minutes.
- For porous substrates, apply a second application at the rate of  $5\text{ m}^2$  to  $7\text{ m}^2$  /litre, and allow to dry.
- Remove as much excess product as possible and clean tools and equipment immediately after use with soapy water.

**COVERAGE: 5L covers up to  $30\text{ m}^2$**   
(depending on porosity and texture of the surface).

## SHELF LIFE & STORAGE

24 months from the date of manufacture in the original unopened container. Store locked up in a dry place between  $5^{\circ}C$  and  $30^{\circ}C$  in the original container.

## HEALTH & SAFETY:

Keep out of reach of children.  
Do not get in eyes, on skin, or on clothing. Wear protective clothing, eye protection, face protection. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. IF ON SKIN: Wash with plenty of soap and water. If skin irritation or rash occurs: Get medical advice/attention. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical advice/attention if you feel unwell.
